RE: Susan Storm – Boats/Watercraft Ownership Report

As requested, we initiated and completed a watercraft ownership search investigation on Susan Storm in the State of California. The results of our investigation are as follows:

Watercraft Search – California (DMV)

A current search of registered watercraft with the California Department of Motor Vehicles (DMV) Watercraft Division revealed **one (1) record** of a boat/watercraft registered to the subject at her last known residential address. Details as follows:

1. Watercraft Type: Sailboat – 38-foot sloop

****Note:** There are exceptions to California’s boat licensing laws. The following watercraft are exempt from obtaining a California DMV-issued boating license: (1) sailboats under eight (8) feet in length; (2) vessels propelled by rowing or paddles; (3) vessels brought to California for racing purposes; and (4) vessels registered in other states, that are primarily used outside of California. (*Source:* California Dept. of Motor Vehicles.)
